2. If the Board is not satisfied that the Applicant is not a fit and proper person to be registered as a Dealer or Salesman under Section 15 of REDDA;

such applicant will not be granted a Licence by the Real Estate Board to practice Real Estate Business under the Act (REDDA).

Students are reminded that any person who practices Real Estate Business without a Licence is liable to a fine or imprisonment or both under Section 44 of REDDA.
